



Budget and School Fees 2024

As per the South African Schools Act No 84 of 1996 and Government Notice No 1293 of 12 October 1998. Glenvista High School is a section 21 Quintile 5 fee paying school.

- The basic annual school fee for 2024 recommended by the Governing Body and approved by a majority of parents at the budget meeting held on the 13th December 2023. The budget for 2024 was presented and approved by the parents/guardians on the 13th December at the SGB Annual General Meeting.

Resolution 1: It was adopted for compulsory school fees for the year 2024 totalling to an amount of R22 074.00 per annum.

Resolution 2: We the as the parents of Glenvista agree that the registration and re-registration fee of R3000 is payable before the 31st of December 2023

School fees are payable in advance and are due on the first day of the school year 2024.

Monthly payments can be made by Debit Order/EFT/Card payments.

Bank Charges:

The Governing Body has decided that any bank charges debited against the schools account because of unpaid debit orders, will be debited to the defaulting payers' account.

Please note the following resolutions are in place:

Resolution 3: We the parents of Glenvista High School, resolve to be a fee-paying school. School fees will be determined for 2024 and charged by the school.

Resolution 4: We, as parents/ guardians of Glenvista High School approve the budget for 2024, as tabled, which reflects the estimated trends of non- payment and the exemptions likely to be granted to parents in terms of applicable legislations.

Resolution 5: We the parents of Glenvista High School agree to apply partial or conditional exemption of parents who are unable to pay compulsory school fees as specified in the regulation for the Exemption of parents from payment of school fees, 2005, as amended.

Resolution 6: We the parents of Glenvista High School authorise the school Governing Body to make payments to Government employed members of staff in terms of section 38A of the South African Schools Act as reflected in the budget tabled.





Resolution 7: We the parents of Glenvista High School agree that in terms of section 39 of the South African Schools Act No 84, 1996, you are liable to pay compulsory school fees. In terms of section 40 & 41 of the South African Schools Act the School Governing Body of a public school may enforce this payment by taking legal action against you.

Resolution 8: The finance department to send monthly accounts to Grade 12 parents and follow up on unpaid school funds. In the event of non-payment legal action should be taken immediately on default and judgement should be sought.

Very important:

The Gauteng Department of Education only pays for 36 of our educators and is not in a position to add to these numbers. The school's in-take is increasing annually and thus has found it necessary to employ educators who are paid by parents in order to offer quality education and accommodate all learners. Furthermore, the school is obligated to pay for all services itself including water and electricity, rates and taxes, toilet paper, soap, toiletries for girl children, sporting equipment and sporting events and so much more. If parents do not fulfil their obligations to pay school fees, we will be unable to retain the services of these skilled additional educators.

- School fees are a statutory obligation. Parents irrespective of their marital status and/or personal arrangements are jointly and severally liable in law for their school fees.
- Accounts of parents who default on payment will without exception, be handed over to our attorneys for collection.
- Judgement could be taken against either or both parents for the principal debt with costs, which would result in your being blacklisted.

Kindly note that this letter serves as a notice in terms of section 41(5)(a) of the South African Schools Act 84 of 1996, you are entitled to apply for a reduction, partial or conditional exemption from school fees, in which event you are to indicate your intention to apply whether you require assistance with such application. Applicants must be prepared for an exhaustive investigation supported by documentary proof into their financial circumstances and lifestyle. This is an annual application to the SGB which needs to be completed before the end of March 2024 and annually. The income of both parents irrespective of their marital status. In terms of Family Law, parents are jointly and severally liable for payment of school fees.
